Dear Parents and Guardians,

On the 5th of May this year, the Victorian State Government announced a \$148 million Camps, Sports and Excursion Fund (CSEF). This fund assists eligible families to cover the costs of school trips, camps and sporting activities.

The CSEF is an annual payment to the school of the eligible applicant. Foster parents and families who held a valid means-tested concession card on April 13th, 2015 are eligible to apply for \$125 per primary school student and \$225 per secondary school student.

CSEF payments will be processed directly to schools and are expected to commence from term three each year. The money is paid directly to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

At Ararat Primary School, CSEF funding may be used for:

- Prep 2 Swimming Program
- Grade 1 Late Night
- Grade 2 Sleepover
- Grade 3/4 Camp

- Grade 5 Camp
- Grade 6 Camp
- Black Ranges Sporting Events
- Any other excursion

Payments cannot be made retrospectively, that is for events that have already happened, however any unallocated amounts may be carried over into next year. These funds may still only be used for camps, excursions or sporting activities.

Applications for the Camps, Sports and Excursion Fund close on Friday, 26th June - the last day of Term Two.

Payments are expected to be finalised by the end of term three each year.

Information for Parents

Camps, Sports & Excursions Fund (CSEF)

Every Victorian child should have access to the world of learning opportunities that exist beyond the classroom. The Camps, Sports and Excursions Fund will ensure that no student will miss out on the opportunity to join their classmates for important, educational and fun activities.

School **camps** provide children with inspiring experiences in the great outdoors, **excursions** encourage a deeper understanding of how the world works and **sports** teach teamwork, discipline and leadership. All are part of a healthy curriculum.

CSEF will be provided by the Victorian Government to assist eligible families to cover the costs of school trips, camps and sporting activities.

If you hold a valid means-tested concession card or are a temporary foster parent, you may be eligible for CSEF. The allowance will be paid to the school to use towards expenses relating to camps, excursions, or sporting activities for the benefit of your child.

The annual CSEF amount per student will be:

- \$125 for primary school students
- \$225 for secondary school students.

CSEF eligibility

Below is the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

Criteria 1 - Eligibility

To be eligible for the fund, a parent or legal guardian of a student attending a registered Government or non-government Victorian primary or secondary school must:

- on the first day of Term two, or;
- · on the first day of Term three;
- Be an eligible beneficiary within the meaning of the State Concessions Act 2004, that is, be a holder of Veterans Affairs Gold Card or be an eligible Centrelink Health Care Card (HCC) or Pensioner Concession Card (PCC) holder, OR
- 2. Be a temporary foster parent, and;
- 3. Submit an application to the school by the due date.

Parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above

Criteria 2 - Be of school age and attend school in Victoria

School is compulsory for all Victorian children aged between six and 17 years of age inclusive.

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. Typically, these students are aged between five and 18 years inclusive.

CSEF is not payable to students attending pre-school, kindergarten, home schooled, or TAFE.

Eligibility Date

CSEF eligibility will be subject to the parent/legal guardian's concession card being successfully validated with Centrelink on the first day of either term two (13 April 2015) or term three (13 July 2015).

Payment amounts

CSEF payment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- Primary school student rate: \$125 per year.
- Secondary school student rate: \$225 per year.

For ungraded students, the rate payable is determined by the student's date of birth. For more information, see: www.education.vic.gov.au/csef

How to complete the application form

NOTE: ALL SECTIONS MUST BE COMPLETED BY PARENT/LEGAL GUARDIAN

1. Complete the PARENT/LEGAL GUARDIAN DETAILS section.

Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your Centrelink card - unless you are claiming as a Foster Parent or Veterans Affairs Pensioner. You will also need to provide your Centrelink card to the school.

If you are claiming as a Foster Parent or a Veteran Affairs Pensioner, tick the appropriate box. In this case, you will need to provide a copy of documentation confirming your status as a temporary Foster Parent or provide your Veterans Affairs Pensioner Gold card to the school.

The CSEF payment is paid directly to your child's school and will be allocated by the school towards camps, sports and/or excursion costs for your child.

- 2. Complete the STUDENT/S DETAILS section for students at this school.
 - enter SURNAME AND FIRST NAMES in full.
 - enter the DATE OF BIRTH e.g. 15/09/2008.
 - enter the YEAR LEVEL, unless the student is ungraded, e.g. attending a Special School or
 - language Centre, then enter 'UNGRADED' in the YEAR LEVEL column.
- 3. Sign and date the form and return it to the school office.

CSEF payments cannot be claimed retrospectively for prior years.
